**Unfortunately we cannot allow any friends or family to accompany the models. Please arrange that your models are being managed constantly and that they have a comfortable experience.**

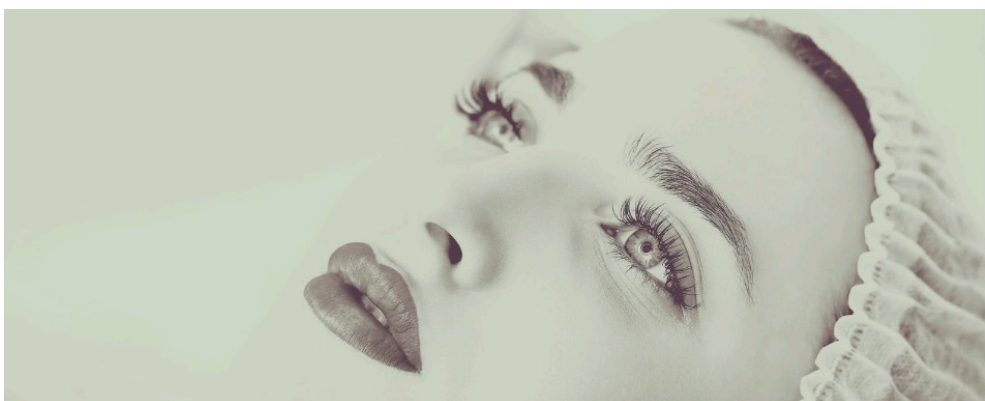
Provide a safe, healthy and clean business environment.
